IT IS IF YOU LIVE NEAR A CELL TOWER!

RADIATION EMITTED BY CELL TOWERS: A HEALTH HAZARD

Radiofrequency/microwave radiation emitted by wireless technology causes an array of biological effects termed radiofrequency or microwave sickness by the Soviets.

Depression, anxiety, irritability, poor sleep, lowered pain threshold, and cognitive, cardiac and neurological effects were causally linked to exposure to wireless radiation decades ago and are increasingly common in today's wireless society.

Wireless radiation is also implicated in causing pre-diabetes. Thus, from a public health standpoint, society is showing signs of experiencing widespread harm from the use of wireless technology. In cell tower studies, people in areas of higher exposure show higher rates of symptoms, including cancer, than those who are less exposed.
